NEW BUSINESS

D. Van Fossan shared his time on the boat with PLM in his Survey Bear Lake 7/14/2022. They noticed increase in native plant species as compared from years past. That's GOOD NEWS it helps reduce algae concentration. Algae along shorelines minimal to Non-existent. Mostly present in small coves, Fenner's Ditch and near Bear Lake Channel Entrance both sides plus in the channel up to the bridge. Sparse presents of Mil-foil Mostly on the N. Muskegon side where treatment was not done in the Spring. Laketon Township side small amounts found sporadically.

GVSU/AWRI update. A. Steinman currently doing water quality testing. Once completed Will compile results.

Board was given option to try using Circulators for Fenner's Ditch. Cost is \$2175 to \$2,075. Plus approximate cost of electricity \$85 per month.

P. Pek suggesting waiting to see if phoslock treatment will work on Fenner's Ditch and have circulators as an option.

BLT Expansion was mentioned regarding the NM City Council Meeting on Monday, July 18th. The Board would like to suggest to new owners of BLT about placing a sign Regarding boat and Bilge washing to stop invasive species from invading Bear Lake With all the boat traffic.

Lenore Chapple 570 Bear Lake Rd. stated how impressed she was with this year's BLLB Board compared to last year's.

BOARD COMMENTS

B. Moore Contacted D. Van Fossan stating the pond across the Witham Bridge from Bear Lake should not of been treated when Bear Lake was treated. Moore stated the Pond was owned by Muskegon County and BLLB would have to pay to have any plant Species replaced that were harmed during the treatment of the pond. D. Van Fossan Contacted EGLE and they stated all the proper protocols were met with the treatment Of the pond. D. Van Fossan also contacted Matt Ferrar from Muskegon County and he Was also ok with the pond being treated.
